

Reason for recall	Following routine quality tests, Woolworths is recalling Woolworths branded 100% APPLE JUICE 200 ml cartons (single boxes and six packs) with the best before date of 23, 28 and 29 March 2022. It was identified that the apple juice in these products contains levels of patulin above the regulatory limits. Patulin is a naturally occurring mycotoxin produced by mould and is commonly associated with apples.	
5. Date and circumstances under which productdeficiency was discovered	Woolworths received the test results 8 October.	
 Evaluation of the risk involved with deficiency(if any testing done , results should be indicated) 	Whilst patulin is undesirable in levels that exceed the legal limits (>50 ppb), there is a low risk that it may cause illness or adverse reactions such as nausea, gastrointestinal disturbances and vomiting.
